Arkansas Works Demonstration Transition and Phase-Out Plan

The authority of the Arkansas Works Act of 2016, which provides coverage to the New Adult Group described at Section 1902(a)(10)(A)(i)(VIII) of the Social Security Act and which provides authority for the Arkansas Works Section 1115 Demonstration Project, expires on December 31, 2021. As required in the Arkansas Works Demonstration's Special Terms and Conditions (STCs), the state has developed a plan for transition of the current Demonstration as follows.

In the most recent session of the Arkansas General Assembly, Governor Asa Hutchinson and the state legislators collaborated to make further improvements to the current program through the Arkansas Health and Opportunity for Me Act of 2021 ("ARHOME"). Under the authority of Act 530, Arkansas proposes to continue coverage for the New Adult Group and to extend and amend the Demonstration through December 31, 2026. The ARHOME program and Demonstration do not reduce eligibility or benefits.

The Arkansas Department of Human Services (DHS) has responsibility for administering the Medicaid program including the Demonstration. DHS will submit the ARHOME waiver application for public comment in June 2021. At the same time, DHS will submit this draft transition and phase-out plan for a 30-day public comment period. There are no recognized tribes in Arkansas to meet the tribal consultation requirements. The state will provide a summary of each public comment received, the state's response, and a description of how the state incorporated feedback.

DHS has developed the following plan for transition, phase-out, and termination according to federal rules and the STCs. Although required to submit this draft plan to the Centers for Medicare and Medicaid Services (CMS) for review and approval, the state does not expect to terminate or close the Demonstration prior to the date of expiration.

DHS has begun an extensive outreach and education strategy to educate the public on the changes due to Act 530 and to rebrand the Demonstration as ARHOME. The transition and phase-out plan will coincide with the public comment period for the ARHOME Demonstration so the public understands that, while the current Demonstration expires December 31, 2021, the ARHOME Demonstration will begin on January 1, 2022, and there will be no lapse in eligibility or coverage. However, termination and closure would be implemented only if the ARHOME Demonstration is not approved by CMS. Implementation of phase-out activities would not occur earlier than 14 days after CMS approval of the Transition and Phase-out Plan.

DHS will submit a draft final report on Arkansas Works within 120 days of the Demonstration expiration (December 31, 2021) to CMS for comments. The final report is due 120 days after receipt of CMS's comments. The state shall provide two Summative Evaluation Reports for the Arkansas Works Demonstration:

- The first is due within 210 days of the end of the Demonstration period, i.e., July 28, 2022. This report shall include documentation of outstanding assessments due to data lags to complete the summative evaluation.
- The second is due within 500 days of the end of the Demonstration period, i.e., May 15, 2023. The State will respond to CMS's comments and submit the final Summative Evaluation Report within 30 days after receipt of CMS's comments.
